### Sexual Misconduct Disciplinary Actions - 1 October 2023 - 30 November 2023

#### Court-Martial

Sexual Assault, Article 120, UCMJ - A Specialist 4 sexually assaulted a civilian victim by committing a penetrative sexual act without the victim's consent. The Specialist 4 was found guilty by a General Court-Martial and sentenced to a dishonorable discharge, 15 days hard labor without confinement, and reduction to the grade of E-3.

#### **Administrative Action**

Sexual Harassment, Article 92 - A Master Sergeant committed sexual harassment in violation of Department of the Air Force Instruction 36-2710, *Equal Opportunity Program*, by making repeated, unwelcome comments of a sexual nature in the workplace. The Master Sergeant received a Letter of Reprimand.

### Nonjudicial Punishment

Sexual Harassment, Article 134, UCMJ - A Staff Sergeant repeatedly made inappropriate comments of a sexual nature to junior ranking airmen in the workplace. The Staff Sergeant accepted an Article 15 and received punishment of reduction to the grade of E-4 and a reprimand.

#### Nonjudicial Punishment

Sexual Harassment, Article 134, UCMJ - A Sergeant repeatedly made inappropriate comments of a sexual nature to a junior service member in the workplace, creating an intimidating, hostile or offensive work environment. The Sergeant accepted an Article 15 and received punishment of reduction to the grade of E-4 and a reprimand.

Sexual Harassment, Article 134, UCMJ - A Specialist 4 repeatedly made inappropriate comments of a sexual nature to a junior service member in the workplace, creating an intimidating, hostile or offensive work environment. The member accepted an Article 15 and received punishment of suspended reduction to the grade of E-4, suspended forfeitures of pay, and a reprimand.
